1		To approve divestment by way of sale, transfer or disposal of investment made by the Company in the equity shares of M/s. Bikewo Green Tech Private Limited (formerly known as M/s. Right Automobiles Private Limited).

The Company has engaged the services of Central Depository Services (India) Limited for providing remote e-voting facility to its members.
